On 9/5/2022 at approximately 6:38pm, Arresting Officer W. Whitman #11234 and Arresting Officer S. Mihai #12252 responded to a Disturbance Armed Encounter in a Vehicle at 8445 S Lancaster Rd, Dallas, Dallas County Texas. Comments on the call sheet stated that there was a disturbance occurring at the incident location within a vehicle, described as a red Dodge Ram 1500, between a hispanic female and a black male. Comments stated that the hispanic female was in possession of a gun and waving it around within the vehicle. Upon arrival, Arresting Officers located a red Dodge Ram 1500 bearing Texas license plate# RGX4020 parked at pump 1. Arresting Officers approached the vehicle and observed Complainant Victor Davis to be within the driver seat, and located Arrested Person Rachel Gaucin partially standing within the vehicle between the front and rear middle seats. Arresting Officers removed both Complainant Victor Davis and Arrested Person Rachel Gaucin from the vehicle. Arrested Person Rachel Gaucin exited the vehicle from the rear passenger door and as she exited the vehicle Arresting Officer W. Whitman #11234 observed a handgun to be in plain view positioned on the rear middle seat floorboard. Arresting Officer W. Whitman #11234 also observed a small switchblade knife positioned on top of the front passenger seat of the vehicle. Due to the nature of the call and there being a handgun and knife in plain view within the vehicle, Arresting Officers placed both Complainant Victor Davis and Arrested Person Rachel Gaucin in handcuffs for safety.
